RELEASE, PERMISSION, AND INDEMNITY AGREEMENT

Waiver In consideration of being permitted to participate in any way in The Meals on Wheels, Bluffton-Hilton Head Pickleball Tournament, I, for myself, my heirs or assigns, do hereby release, waive, discharge and covenant not to sue Sea Pines Country Club or Meals on Wheels, Bluffton-Hilton Head, its officers, employees and agents from liability from any and all claims resulting in personal injuries, accidents or illness (including death) and property loss arising from my participation in the tournament. I also agree to indemnify and hold Sea Pines Country Club, Meals on Wheels, Bluffton-Hilton Head (Sea Pines Property Owners?) etc., harmless from any and all claims, actions, suits, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Tournament.
